We have a virtualized environment already running. This will be used to install the EDMS
2	What kind of CRM do you have? Is the Oracle System that was mentioned of Oracle Financials and if so, which version is it and which modules will be integrated with? Same case for CRM. And lastly, are both on premise or in the cloud?	We are running Oracle Business suite ERP and Microsoft Dynamics CRM. We shall provide the specific versions to the winning Bidder.
