2. Tendering will be conducted under the Open National competitive method using the standardized tender document. Tendering is open to all qualified and interested Tenderers.

Eligible and interested bidders may obtain further information and inspect the bidding documents at Supply Chain Office at the Kenya Trade Network Agency (KenTrade) Headquarters on 1st Floor, Embankment Plaza, Upper Hill between 8.00am and 5.00pm Kenyan Time, Monday to Friday except lunch time between 1.00pm to 2.00pm and on public holidays.
4. A complete set of tender documents may be obtained by interested candidates upon payment of a non-refundable fee of Kshs. 1,000/= (One thousand shillings only) deposited in KenTrade's Co-operative Bank Account no. 01141162178000, Account Name: Kenya Trade Network Agency, Upper Hill Branch.

7. Prices quoted should be inclusive of all taxes and service delivery costs, must be expressed in Kenya shillings and will remain valid for **175 days** from date of tender opening.

All tenders must be accompanied by a tender security worth **Kenya Shillings One Hundred Thousand (Kshs. 100,000.00)** and valid for **150 days** from the date of tender closing in any of the following forms: a bank guarantee; a guarantee by an insurance company registered and licensed by the Insurance Regulatory Authority and listed by PPRA.
9. Tenders **MUST** before tax factor into their cost an additional **0.03%** PPRA Capacity Building Levy.
